

## Message from the President & Executive Director

There is reason to celebrate the Foundation's ten years of activity:

- Total assets at \$1,524,082
- Distributed \$583,007 (471 grants) to our local community organizations
- Administered allocations for Cedar Ridge Pops Festival for local charities totalling \$513,880 and for Physicians Recruitment totalling \$433,140
- Volunteer involvement we cannot function without these people:
  - The Professional Advisors Committee has been re-established by Ted Symons.
  - Thanks to the initiative of Jane Barnett, the Youth in Philanthropy program was revived.
  - Ryan & Kelly Donaldson, designers of our original logo 10 years ago, volunteered to develop our new logo, and we believe it truly reflects our continued growth and support in our community.
  - We are extremely proud to be associated with Nicole French, and her business Home Cooked Website Solutions Inc. Nicole has committed to completely redesign our website, providing a new

look, easy navigation, and update for a our new logo, vision and mission statements.

- Steve Whittington is preparing audio visual material describing who we are and what we do.
- Our Foundation and Georgian Bay Land Trust have formed a partnership to raise a total of \$20,000 by December 2012. This fund will be matched dollar for dollar. The resulting \$40,000 will provide a permanent endowment Foundation fund to steward the conservation of our area of Georgian Bay.
- We have been working with the three other community foundations in Simcoe County – those in Orillia, Barrie and Bradford West Gwillimbury. A proposal has been submitted to the Ontario Trillium Foundation.
- The fourth Annual Philanthropy Circle of Honour Awards was a great success. Again it reminded us of the generosity of members of our community.
- Retiring from our Board are Alison Durtnall, Bill Jamieson, Dr. Pam Chart, Susan Robillard and Ted Symons. Thank-you for your commitment to our community.

This year is one of transition. Our goal is to build on the successes we have achieved so far:

- 51 Funds created by local philanthropic families, businesses and agencies delivering grants that are responsive to the needs of our communities.
- Grants in 2010 total \$45,308. Our goal is \$100,000 per year.
- Investment ROI net of fees in 2009-10 was 17.3%

Our 10th anniversary gives us a decade to be thankful for the donors, volunteers and friends of the Foundation who give back to the community that will make a difference for Today, Tomorrow and Forever.

## Message from the Grants Chair - Michelle Pilon

The Grants Committee allocates the Grants from monies available in the Unrestricted Funds, Field of Interest Funds and the Flow-through Funds. The grant money for spring 2010 was close to \$20,000. The grants were awarded to the following applicants:

- Angels with Backpacks: \$1,000 grant to provide backpacks, filled with essentials and distributed to those in need by the Out of the Cold Program, the Salvation Army and the Midland Police Services.
- Askennonia Senior Centre: \$960 grant to provide transportation costs to/from the Centre for six seniors to attend each of eight events at the Centre.
- Atlantic Challenge Canada: \$1,302 grant for the cost of "Inukshuk" awards being made by Community Living Huronia.
- Beausoleil First Nation Public Library: \$1,000 grant to provide an update to both the Aboriginal and the Best Seller book collection.
- Big Brothers Big Sisters of North Simcoe: \$1,000 grant for various expenses incurred with the Friend for a Day program.
- **Boys and Girls Club of North Simcoe: \$1,000 grant** to provide funds for the "healthy snack" component, part of the After School Program.
- Catholic Family Services: \$1,000 grant expenses for the new Taming the Tiger anger management program for women.

- Georgian Bay General Hospital: \$1,000 grant contributes monies pledged to the Hospital's Our Best Care campaign.
- Gift of Grace Soup Kitchen Knox Church: \$1,000 grant to provide much needed funds for the general food needs of the soup kitchen.
- Habitat for Humanity North Simcoe: \$948 grant to assist with the promotion of the new ewaste recycling program at the Midland ReStore.
- Midland Domestic Assault Review Team (known as DART): \$1,000 grant for the cost of posters and artwork on workplace violence and harassment
- Scientists in School: \$2,000 grant to the Science Outreach Program to fund one additional grade 6 workshop and a local teacher workshop.
- Wendat Community Programs: \$1,000 grant to defray costs of appliances for the Healthy Eating Program of Social club and Seniors day.
- YMCA Camp Kitchikewana: \$1,115 grant to provide funds to allow a 2 week overnight camper session as part of the Strong Kids Campaign.

This Fall, in celebration of the Foundation's 10th year, the Grants Committee will award a special Grant of \$5,000. This new Grant will focus on proposals which will have an impact on the community. This is the first time a Grant of this size will be made. The focus will be Innovation and Impact.

Thanks to all those involved, the Charities, the Huronia Community Foundation Board and its various Committees and our local Media for the opportunity to make a difference in our community. Next year, Helmut Paddags will take the helm as Chair of this committee. We look forward to the opportunity to work with him.

#### **Fund Definitions**

*Community Unrestricted Endowment Funds* This is a general Fund that gives the Foundation the greatest flexibility in awarding Grants to charities. This type of Fund is not tied into any specific charity or area of interest, allowing the Foundation to respond to the immediate and changing needs of the community.

#### Designated Endowment Funds

This type of Fund gives the donor the opportunity to specify, at the time the Fund is established, which particular charity or charities they would like to support in perpetuity.

#### Field of Interest Endowment Funds

Donors identify an area of interest that they would like their donation to support. Examples include the arts, environment, health, seniors, children, youth, recreation, relief of poverty, or education.

#### Managed Funds

Managed Funds are on behalf of charity or charitable group with the annual returns periodically distributed back to the group.

#### Flow-Through Funds

The capital and income from these Funds are distributed over a one year period.




### Message from the Investment Chair & Treasurer - George Cornell & Blair Stotesbury

We are pleased to report to our fund holders, donors and community partners our financial results for the fiscal year ending March 2010. Our investment portfolio is pooled with the funds of the Toronto Community Foundation, which gives us access to investment expertise on a national and international scale. We mark our 10th year as a foundation having \$1,524,082 in assets. Our return on investment last year, net of fees, was 17.3% despite the recent turmoil in the global financial markets.

The investment committee will move forward over the next year to improve our reporting procedures and to continue its investment stewardship with prudence and care.

**Endowment donations** are held in perpetuity and the earnings are used to support community groups. **Managed Fund** contributions such as for the Medical Student Scholarship program are not held in perpetuity but are invested over time . **Flow-Through contributions** are distributed over a one-year period.


